SIXTY YEARS OF SUCCESS STORIES

As I look back on this past year, I continually catch myself looking toward next year and the celebration of GDA's 60th Anniversary.

Everyday I am surrounded by and reminded of the great and small accomplishments of our graduates that have been fueled by their personal commitment to living a life with increased mobility and independence. Today, GDA helps make these accomplishments possible for our students backed by the resources of a dedicated staff, hundreds of deeply committed volunteers, and many generous donors. But behind the 40 to 50 guide dog teams we now graduate each year and the thousands of teams we have graduated over the past 60 years, was the determination of one man who knew his mobility needs would best be met by using a guide dog.

At the age of 57, Joseph Jones became visually impaired. He was in need of a guide dog, but could not find a guide dog school to meet his needs. At GDA, we continue to carry out the vision of Mr. Jones who, with the help of the International Association of Machinists and Aerospace Workers, founded the school and ensured it would have a policy of no upper age limits. Led by our mission, we welcome blind and visually impaired men and women from throughout the United States and Canada and provide them with guide dogs and the instruction in their use, free of charge.

We are proud of our past, thankful for all that we have in the present, and excited about our future. As this year comes to a close, we extend our sincere gratitude to all of you for your continuing support of GDA, and send our best wishes to you and your family during the holiday season and throughout the New Year.

VET'S CORNER

GDA'S HOLIDAY GIFT GUIDE FOR YOUR PAMPERED POOCH



The holidays are a time for giving. For most of us there is a special dog or dogs that deserve a little something special to celebrate the holiday season, too. GDA offers several helpful guidelines for gift giving — key among them, taking into consideration the age and size of your dog — to make you and your dog's holiday season happy, healthy, fun, and safe.

Have a Ball! – When purchasing a ball or toy for a dog, make sure it's large enough that it won't lodge in its throat. A dog's primary designs on a toy are carrying it in his mouth, chewing it, tossing it, and catching it, so it's important that the toy is too big to swallow.

Give Your Dog a Bone – Choose a bone that matches your dog's chewing rate and chewing habits. If your dog chews for short periods of time with a soft bite, a smaller rawhide bone that softens easily will be enjoyable. For more aggressive chewers harder bones will last longer and be more satisfying. Supervise chew time, and throw away bones that have become small enough to be swallowed.

Fashion with Function – A monogrammed leash and collar or a fancy new name tag that includes your home telephone number will ensure your dog's safe return if you become separated.

What a Treat – Treat dispensing toys in ball or other shapes make ideal gifts. Designed with hollow areas that can be filled with your dog's favorite (and healthy) treats or natural peanut butter (provided your pet is not allergic), these toys are great for keeping your dog occupied for long periods of time.

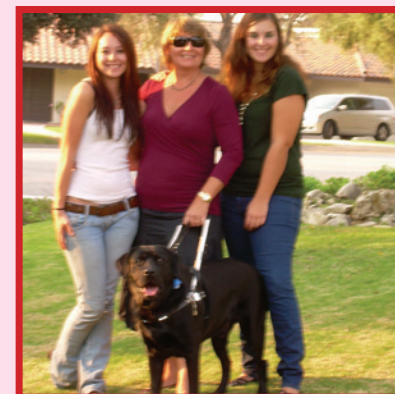
Holiday Cookies – Your dog shouldn't be fed any of your homemade holiday treats except those made from recipes specially-formulated for dogs and/or your dog's dietary restrictions. You can find wonderful recipes online or in doggie cookbooks.

Paws with a Cause – If everyday is a holiday for your pampered pooch, consider giving a gift in your dog's name to Guide Dogs of America. Check out our "Holiday Wish List" in this newsletter, or make a donation in any amount to help support our program.

A good dog gift is one that does not cause harm to your dog. With just a little forethought, you and your dog will enjoy a safe holiday season. 🐾

be difficult. As her vision deteriorated, it became more difficult to find clothes in her kids' sizes. Not realizing she was visually impaired, people were hesitant to offer her assistance. That changed when she received her first guide dog, Walker. "He has opened my world. Walker is my ambassador," said Christie. Together for more than three years, Christie and Walker easily navigate through crowded stores, and Christie is approached more frequently with offers of assistance. Every Christmas there is a special present under the tree for Walker – always packaged in the same gift bag with a picture of a yellow Labrador Retriever. "Walker knows that it is his bag and he goes right to it," said Christie.

This will be Terri Kruger's first year having a guide dog, and she is looking forward to it. She and Pontero graduated last February. Legally blind since birth, Terri had always "made do" until four years ago when her vision further deteriorated as a result of glaucoma, and she began using a cane. She used her cane until she arrived at GDA earlier this year. Teamed with Pontero, Terri enjoys the freedom and mobility having a guide dog has brought her. "During the holidays, I like to get out there and see and feel everything and get ideas. I want to find just the right thing," she said. "I think Pontero and I are going to have a lot of fun shopping together." Terri has two daughters, Jennifer, 19 and Antoinette, 18, and said she had to get more creative as the girls got older and grew out of toys and dolls. She also has had to become a better planner. "Pontero and I will probably do a lot of pre-shopping on our own, and then I'll make arrangements for my husband Jamie, or one of my friends to go back with me to pick up the gifts."

This past September, Chris Sirna graduated from GDA—for the sixth time. Blind since birth, Chris has used a guide dog for almost 30 years. His new guide, Katie, already has become an important member of the family, and this year will spend her first of many Christmases with Chris, his wife Aline, and their three children:

Michael, 26, Tom, 7, and Serenity, 6. As for how having a guide dog and having kids makes the holidays different for Chris, he finds that having a guide dog allows him to enjoy the holidays more. "Instead of having to worry about the congestion and the crowds of the

holiday season, having my guide dog eliminates some of that stress and allows me to enjoy the spirit of the season," he said. "Katie makes it easy for me to go to crowded places and not have to focus on mobility. I am able to concentrate on my kids and the fun they are having."

Nearly twenty years ago, Greg Steinmetz began to lose his vision. Diagnosed with retinitis pigmentosa, Greg gradually lost his sight and began using a guide dog four years ago. Greg enjoys holiday shopping for his wife Tamie and their daughter, Emilee, 14. "Shopping has become much more complicated, but I have found since having Proxy that people are much more willing to help," said Greg. "I can do a lot of shopping online so I don't have to go to stores for everything." But it doesn't keep him from going into the kitchen. "I used to do a lot more of the cooking, and I still make a mean brisket at Hanukah," he said. "For Thanksgiving, I still make the turkey, but I don't do the carving anymore."

Blind since birth and with total vision loss, you might not expect to learn from Lorita Betraun that she loves to decorate the tree and bake cookies for the holidays. "My mom was really into the holidays and she gave that gift to me," said Lorita, for whom Valor is her fourth guide dog. And it's a gift that she is sharing with her family,

husband Michael Brown, and their daughter Michaela Brown, 11, as she warms the house with the smell of fresh baked cookies and decorates the tree with ornaments collected over the years. Lorita employs all her senses to make the holidays enjoyable for her family and to take in all that makes the holidays special for her. "I know the cookies are ready by the smell, and my family loves them," she said. For Lorita, her biggest treat is going to the malls. "I love to go shopping all by myself with my guide dog during the holidays. It's a time of year that involves all my senses – the smells, the sounds of Christmas carols, the electricity of the season – you can feel it all around." This year as she hangs the ornaments on the tree there will be a new one for Valor to mark his first Christmas with Lorita and her family. On the ornament is the image of a black Labrador Retriever. 🐾

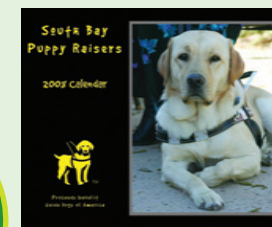

This double benefit can work for appreciated real estate as well as appreciated securities. You also can sell a security that would generate a loss, and donate the proceeds to Guide Dogs of America. That loss could be used to offset other capital gains you may have, or if you have no other capital gains, up to \$3,000 can be used to offset ordinary income.
