Arrive at the Everett Boeing Activities Center for registration between 8:00 & 9:30 a.m. on Saturday, June 10th to sign up.

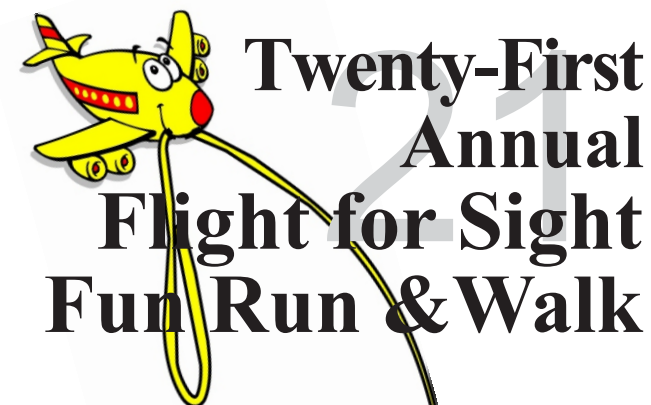
5K (3.1 miles) run/walk at 10:00 a.m.

I wish to participate (or my non-adult family member wishes to participate) in the Flight for Sight 1 mile walk / 5k ("Flight for Sight 1 mile walk / 5k"). In consideration for the right to participate in the Flight for Site 1 mile walk / 5k, I acknowledge and agree as follows:

#### **ACKNOWLEDGMENT OF VOLUNTARY PARTICIPATION AND RULES**

- I acknowledge that my participation (or my non-adult family member's participation) in the Flight for Site 1 mile walk / 5k is entirely voluntary and unrelated to my employment or job duties. I understand and agree that The District 751 Machinist Union ("Machinist Union"), The Boeing Company and its subsidiaries together with its officers, directors, employees, agents, contractors, affiliates, and insurers and reinsurers ("Boeing"), Bell Lap Productions, LLC (Bell Lap), and Databar Events (Databar) does not have responsibility for my activities associated with the Flight for Sight 1 mile walk / 5k.
- I agree to follow all rules, policies and instructions that apply to the Flight for Site 1 mile walk / 5k.

#### **ASSUMPTION OF RISK**

- I acknowledge that any injuries or illnesses that result from my participation in the Flight for Sight 1 mile walk / 5k may not be covered by workers compensation benefits.
- I understand that walking/running is a physical activity that exposes participants to risks of injury and illness. Specific risks include, but are not limited to, heart attack and stroke resulting from physical exertion and injuries to ankles, knees and other parts of the body. I acknowledge that my participation (or the participation of the person I am signing for) in the Flight for Site 1 mile walk / 5k may involve risks of personal injury, illness, and other health effects. I understand these risks and voluntarily agree to assume these risks as a condition of my participation (or the participation of the person I am signing for) in the Flight for Sight 1 mile walk / 5k.
- I certify that I have evaluated my physical condition (or the physical condition of the person I am signing for) and determined that I am (or the person I am signing for is) medically and physically capable of participating in the Flight for Sight 1 mile walk / 5k. If I am unsure whether I am (or the person I am signing for is) capable of participating in the Flight for Sight 1 mile walk / 5k, I will seek the advice of a physician or another competent medical professional before beginning participation in the Flight for Sight 1 mile walk / 5k. If I experience (or the person I am signing for experiences) any abnormal physical symptoms while participating in the Flight for Sight 1 mile walk / 5k, I/we will stop immediately and consult a doctor without delay.
- I acknowledge that the Machinist Union, Boeing, Bell Lap, Databar make no warranty of any kind concerning the property where the Flight for Sight 1 mile walk / 5k will take place, its condition, or its fitness for purpose. I accept (or the person I am signing for accepts) the property in its "as-is" condition and hereby waive, release, and renounce any and all claims against Machinist Union, Boeing, Bell Lap, and Databar relating to the property, its condition, or its fitness for purpose, including claims arising out of tort or alleging Machinist Union, Boeing, Bell Lap, and Databar's fault or negligence.

#### **INDEMNIFICATION AND WAIVER OF CLAIMS**

- As a condition of my participation in the Flight for Site 1 mile walk / 5k, I hereby agree (and the person I am signing for agrees) to indemnify, defend, hold harmless, and release Machinist Union, Boeing, Bell Lap, and Databar from any and all liabilities, claims, suits, demands, judgments, damages, costs (including attorney's fees), and losses for illness, injury, or death to any person, including me (or the person I am signing for), arising from or related to participation in the Flight for Sight 1 mile walk / 5k, including where the illness, injury, or death is caused, in whole or in part, by negligence on the part of Machinist Union, Boeing, Bell Lap, and Databar.
- I also agree, knowingly and willingly, for myself (and for the person I am signing for) and all who may hereafter claim through or for me, to waive any and all claims against Machinist Union, Boeing, Bell Lap, and Databar for liability for illness, injury or death, whether foreseeable or unforeseeable, arising from or related to participation in the Flight for Sight 1 mile walk / 5k, including where the illness, injury or death is caused, in whole or in part, by negligence on the part of Machinist Union, Boeing, Bell Lap and Databar.
- I agree (and the person I am signing for agrees) that the provisions in this Agreement apply to all claims for illness, injury or death resulting from any cause, including claims arising in tort from the negligence of any party released herein. I further acknowledge that this Agreement shall be binding on all of my family members, including minors, guardians, and heirs, and on any executor or personal representative or beneficiary.

#### **CONSENT TO PHOTOGRAPH, VIDEOTAPE AND COLLECTION OF OTHER PII**

- I hereby agree to allow Machinist Union to photograph and videotape my participation (or the participation of the person I am signing for) in the Flight for Sight 1 mile walk / 5k, and I consent to Machinist Union's use of such photographs and video from the Flight for Sight 1 mile walk / 5k for any and all purposes. I waive all claims for compensation, and agree that I will not have any right to review any photograph(s) or video(s) that may be used by Machinist Union.
- The Personally Identifiable Information collected on this form will only be used for the purpose of this event. The forms will be stored securely for three years and then destroyed.

#### **CERTIFICATION OF ADULT AGE**
