DIRECTIONS FOR VETERINARY REIMBURSEMENT

If you have been approved to seek outside veterinary care, please be sure to include the following documentation when requesting reimbursement for the veterinary care.

1. A completed GDA|TLC VETERINARY REIMBURSEMENT REQUEST FORM. The form is available on our website at www.guidedogsofamerica.org > Puppy Raising > Current Puppy Raisers. Scroll down and on the right side is a list of Quick Links. Click on “Veterinary Reimbursement.”
2. A copy of the veterinary/hospital invoice
3. Proof of payment
4. Copy of the medical records/notes from the visit. These will be added to the puppy’s GDA|TLC file. If there are any issues obtaining the records, please reach out to the Vet Department at 818-833-6740.

We ask that you scan and email all documents to vetdept@guidedogsofamerica.org or mail them to the Veterinary Department at the address on the bottom of the reimbursement request form.

Please send the documents in PDF format. We are unable to process emailed photo images (e.g. jpg files.)

Incomplete requests cannot be processed, so please be sure to submit all requested documentation.
